\$17,550 designated to transportation and various areas of need for 10 kids



Pink Shirt Day Campaign raising awarness for bullying prevention and promoting kindness



\$225,625 supported education through tutoring for specialized needs and tuition for 133 children



Specialized educational programs for moderate to severe learning disabilities



\$342,652 helped 160 children access a wide range of therapies and counselling




Behavioral Therapy programs for complex and acute mental health challenges


